# INTRODUCTION

The 2020 North American Barley Scab Evaluation Nursery (NABSEN) was grown at Fargo, Langdon, and Casselton, ND; St. Paul and Crookston MN, and Brandon, Manitoba. Nurseries either were misted or non-misted (dryland). Dryland nurseries provide conditions similar to those found in commercial fields. Disease in misted fields was more severe than growers would observe in most years and entries with only moderate FHB resistance may have higher disease levels. Dryland nurseries allow discrimination of entries with moderate to low levels of FHB resistance. Each nursery included a set of common checks. The checks were Chevron, Quest and ND20493 (resistant six-row checks), Robust and Stander (susceptible six-row checks), and Conlon (resistant two-row check). At all locations percent severity of FHB was determined around the middle dough stage by determining the ratio of infected kernels to total kernels on 10-20 spikes per entry, and then multiplying by 100.

#### **RESULTS**

FHB disease severity was not taken at Casselton dryland nurseries. FHB disease severity levels were moderate at Fargo, ND and Brandon, MB and high Langdon, ND, St. Paul and Crookston, MN in 2020. DON levels were high at Langdon and St. Paul and moderately high in Fargo, Brandon, and Crookston, MN. The lowest DON levels were in these lines: S2M180 8.6; 2ND37598 8.7; 2ND32829 9.0; HB19136 9.8 and S2M179 9.8, these were equal to or less then the resistant 2-rowed variety; Conlon which had 9.8 ppm DON. The two dryland locations at Casselton had low DON levels (Table 4).

Temperatures were below the 30-year average (Table. 6), for May at all locations. All locations were above the 30-year average for June and July. August temperatures were generally average at all locations except for St. Paul which was above the 30 year-average (Table 6).

Precipitation were below the 30-year average at all locations in May except for St. Paul which was 1.5 in. above normal. June precipitation were average at all locations except for St. Paul which was above the average by 2.5 in. July precipitation was above the average except for St. Paul which was about 1.0 in. below. Only Fargo and Casselton locations had above average rainfall in August (Table 7).
